NOW ALL YE MEN AND NATIONS, the Privy Council for the Interim Provisional Government for the Kingdom of Hawai'i hereby declares and proclaims that the pursuant to *Resolution 03-0123-001* the following action will be finalized and enforced, to wit:



T is hereby proclaimed that the Order of Kamehameha I and all variations and factions thereof are subject to the authority of the Privy Council for the Kingdom of Hawai'i including the current Royal Order

of Kamehameha I and the derivative known as the Anti-Royal Order of Kamehameha I;



T is further stated that the Privy Council is fully authorized to implement all means necessary to accomplish the task aforesaid, within the purview of the Law of Nations, Constitution for the Kingdom of Hawai'i (1887), Laws and Statutes of the Kingdom of Hawai'i, the Statutes of the Order of Kamehameha I, and so forth, as deemed appropriate and necessary;



T is hereby declared that all alien clandestine rituals & practices, and secret societies abhorrent to the Kingdom of Hawai'i and its Constitution and Laws are null and void:



T is hereby declared that all offices and positions of the Order of Kamehameha I, and subordinate chapters and auxiliaries are hereafter declared Vacant until authorized by the Privy Council, and that anyone attempts to usurps any office or authority of the Order of Kamehameha I will be dealt with accordingly;



T is hereby required and demanded that all funds, dues, monies, and assets be transferred to the Minister of Finance, and all records and data of the Order of Kamehameha I, be turned over to the Minister of

the Interior immediately.

Caveat

OTICE is hereby given that anyone that violates or impedes the Privy Council in the matter of the Order of Kamehameha I, may be subject to the *Law of Nations*, the Constitution for the Kingdom of Hawai'i, the Laws of the Kingdom of Hawai'i, and any foreign Constitutions and Laws that apply in this matter; and,



hat: any objections be in writing along with all cites and authorities of Law, and sent to the *Privy Council* of the Kingdom of Hawai'i within fifteen (15) days of the this Writ.
